

Of late, relationships between business units, the corporate and the functional organizations are changing at a visibly dynamic pace. The metamorphosis started with functional organizations moving from control to service orientation, then from being a provider to becoming a partner. The series of transformation continues in evolving this partnership to much higher levels in line with the demand of the organization as a whole. Global Capability Centre (GCC) as a descriptor does not by itself entitle a GBS organization to assume they have all the requisite capabilities that are required to become a business or strategic partner to the parent organization. Our interactions with several global corporations and their GCCs reveal that very few have a clear appreciation of the various capabilities required as a GCC, categorise them and then benchmark the current status of these capabilities against the requirements to become a true GCC.

Moving up the process value chain, linkages beyond 'functional' processes to connect 'cross-functional business processes', proactive ownership to drive the end-to-end process beyond what is specifically assigned are some of the positive actions that initiated the creating of sustainable differentiators. These have now become an expectation from GCCs and no longer a differentiator, much less sustainable ones.

Integration with various forms of technologies, especially intelligent technologies, have created arrays of strategic opportunities for such centres to generate value for the enterprise and press the reset button on a periodic basis to ensure they continue to deliver value in a fast-changing business environment and world. A term which is widely used in this context is creating “sustainable differentiator based positive actions”. This Global Conclave brings laser focus on those essential elements that will provide the next leap in becoming an ‘enterprise partner’.
